a) School Capital Project

**Moved by** Councillor Darren MacKenzie and **seconded by** Deputy Mayor Dave Morrison WHEREAS the Hanwell 5-year Capital Plan allocates \$75,000 for a walking track around the multi-purpose field at the school, and

WHEREAS the Hanwell 5-year Capital Plan allocates \$50,000 for a multi-purpose paved surface for racquet-based sports at the school, and

WHEREAS the Hanwell 5-year Capital Plan allocates \$200,000 for a playground, to supplement the \$80,000 that the Province of New Brunswick is allocating for the school playground,

I hereby motion to authorize and direct the Clerk to work with the Province of New Brunswick to see these projects through to completion at the Hanwell School. **Unanimously Carried #23-03-2019** 

b) Hanwell Radio Station project

**Moved by** Deputy Mayor Dave Morrison and **seconded by** Councillor Holly Hyslop WHEREAS a permanently broadcasting radio station can serve the municipality for the communications relating to community events, for the broadcast of emergency services, and information, for entertainment, and for local identity,

I hereby motion to authorize Councillor Darren MacKenzie to work with Paul Dixon of CJRI Radio to establish a permanent radio station within the municipality. **Unanimously Carried #24-03-2019** 

c) Solar grid array project

**Moved by** Councillor Darren MacKenzie and **seconded by** Holly Hyslop WHEREAS the establishment of renewable energy solutions is proven to be of benefit to our environment, and

WHEREAS the rural community of Hanwell's theme is to be "Inspired by Nature", and

WHEREAS Infrastructure Canada has allocated funding for "green" projects within municipalities under the "Investing in Canada" bi-lateral agreement with the Province of New Brunswick, and

WHEREAS there is an economic benefit with a high return on investment to this project,

I hereby motion to authorize and direct the Clerk to proceed with the application for a grant through Infrastructure Canada, in conjunction with the Province of New Brunswick, and NB Power as needed, to move forward with a 100kW solar grid-tied array to be located within the municipal boundary of Hanwell, with the project to be constructed in the year 2020. **Unanimously Carried #25-03-2019**
