## d) Parking Lot Lighting

**Moved by** Councillor Darren MacKenzie and **seconded by** Councillor Dan Fortier to allocate \$21,450 + HST, either via the Capital Reserve or through the current 2020 fiscal capital allocation, to correct the problem that was missed by RSC11, the building engineering firm, and Colpitts and install parking lot lighting with sensors.

Councillor Darren MacKenzie wished to address the parking lot lighting as an issue against light pollution, and has requested that his statement be included in the minutes of this meeting:

Hanwell's motto/slogan is "Inspired by Nature", yet we bleed an insane amount of light pollution in our own parking lot with unshielded and undimmable overhead lighting. The idea that "light prevents crime" is an antiquated idea from days gone by of the 1980s, with many current studies showing that there is no such correlation. Criminology has advanced a great deal since we first had this belief.

A 2015 study in the Journal of Epidemiology and Community Health found that lighting does not prevent accidents or crime, but does cost a lot of money. The researchers looked at data on road traffic collisions and crime in 62 local authorities in England and Wales and found that lighting had no effect, whether the lights were turned off completely, dimmed them, turned them off at certain hours, or substituted different variations of light housings.

Indeed, of what value is lighting an area, when there is nobody watching it? Our own recreation building was vandalized multiple times, even with the intense light in the parking lot. Before our community center was even completed, tools were stolen from it in broad daylight. There is only one house with direct view of the location. Who's watching it? Nobody.

Back to the additional studies, a 2011 study of street lighting and crime showed no evidence that increased lighting reduces total crime. A 1997 National Institute of Justice study concluded "we can have very little confidence that improved lighting prevents crime."

The truth is that intense outdoor lighting can decrease safety by making victims and property easier to see. We've seen this in our own building. A Chicago Alley Lighting Project (April of 2000) showed a correlation between brightly lit alleyways and **increased** crime.

A 2012 report from the American Medical Association stated that "glare from nighttime lighting can create hazards ranging from discomfort to frank visual disability."

But even if we ignore the plethora of current studies and evidence that I have stated here, we should look no further than our own hypocrisy of how we are looking to have an open house, based on Earth Day, nonetheless, talking about various forms of pollution, yet we have a very clear and easy way to correct a major problem with our own light pollution.

Pollution of all forms is bad. Air, water, noise, and light. If we are truly to be "Inspired by Nature", we should look to practice what we preach, and reduce it in any way we can.

We currently have \$225,000 in our Capital Reserves, and could be putting up to nearly another \$153,000 more in it if/after this budget passes. Yet we cannot allocate \$23,000 of this to fix this problem in our own parking lot? I find it truly astounding that there are members of council that are actively against supporting

this initiative.

I understand that some people will still have a *perceived* notion of safety with increased lighting, even though they may not be aware of current studies surrounding this issue. It's human nature to assume that we should feel safer if we are seen, even if nobody is looking at us. Therefore, I am not looking to actually remove parking lot lighting, of course. Lighting is still useful when there are people present, especially when driving. Therefore...since we have obtained a quote from an electrician for this....

I hereby motion to allocate \$21,450 + HST, either via the Capital Reserve or through the current 2020 fiscal capital allocation, to correct the problem that was outrageously missed by RSC11, the building engineering firm, and Colpitts (the construction/contracting company) and **install proper parking lot lighting with sensors**.

Council orders and directs the levying by the Minister of Environment and Local Government of said amount on real property liable to taxation under the Assessment Act within the RURAL COMMUNITY OF HANWELL.
