

2025 Budget

With the municipal reform in 2023, our newly annexed areas of Kingsclear, Oswald Gray, Ludford as well as the areas with streetlights all had separate tax rates. In 2024, we combined Kingsclear and Ludford's residential rates with the Hanwell tax rate. In 2025, we combined all the areas so that there would only be subunits identified as Hanwell and Hanwell Streetlights.

On the property tax bills there are two additional tax rates that are regulated by the province \$0.41(Administration and Road Services - DTI) and \$0.14 (RCMP)

Residential Assessments increased from \$901,366,800 in 2024 to \$988,529,200 in 2025
